Contest rules

The Contest « **25** years in the heart of the neighborhood » (the « **Contest** ») will be held at Les Marchés Tradition in New-Brunswick (each a "**Participating Store**" and collectively the "**Participating Stores**"). It is organized by Sobeys Capital Incorporated (the "**Contest Organizer**"), in partnership with Aliments du Québec (the "**Partner**").

The Contest begins on Thursday, September 21, 2023, at the Participating Store's opening time and ends on Wednesday November 1st, 2023, at the Participating Store's closing time (the "Contest Period").

1. ADMISSIBILITY

TO BE ELIGIBLE TO ENTER THE CONTEST, you must:

- be a resident of New-Brunswick;
- have reached the age of majority in your province of residence at the time of Contest entry; and
- be enrolled in the Scene+® Reward Program* (the "Program").
 (an "Eligible Entrant")

EXCLUSIONS: The employees, agents and/or representatives of the Contest Organizer, its affiliates, Participating Les Marchés Tradition, non-participating affiliated grocers, advertising agencies or any party involved in the administration of the Contest (the "Affiliated Parties") such as employees, agent/or representatives of all the Presenting Sponsors, as well as, respectively, any person with whom an excluded entrant is domiciled or any member of their immediate family (each an "Excluded Entrant"). Enrollment in the Program is free but requires Internet access (free Internet access is available in various public places). By enrolling in the Program, you agree to be bound by the terms and conditions of the Program, which are subject to change periodically.

The Entrant must ensure that the contact information for their Scene+® Member Account (the "Member Account") is accurate at all times so that the Contest Organizer may contact the Entrant, if necessary.

For the purposes of these Rules, the Entrant is the person whose name appears on the Member Account and to whom the Prize will be awarded if they are selected and declared a winner.

Each Entrant must enter exclusively on their own behalf and act for their sole personal benefit.

NO PURCHASE ENTRY

No purchase required. To enter the Contest without making a purchase you must write an original handwritten letter of fifty (50) words or more explaining what is the must-have Canadian Nos Produits d'ici product you like from Les Marchés Tradition. Please provide your Scene+® member number and the address of your Participating Store, your first and last name, address, phone number and email address and place the letter in an envelope addressed to the offices of the Contest Organizer, located at 11281 Albert-Hudon Boulevard, Montréal-Nord, QC H1G 3J5, with the name of the contest, Attn: 25 years in the heart of the neighborhood (a "No Purchase Entry"). The No Purchase Entry must be received by the Contest Organizer no later than the last day of the Contest Period, November 1st, 2023. Given the variability of the mail delivery schedule, the time of receipt for an Entry will be determined at the sole discretion of the Contest Organizer. By submitting a No Purchase Entry, you will be deemed to have read and accepted these Rules and you agree to abide by these Entry requirements of these Rules.

Limit of one (1) No Purchase Entry per Member Account, per day, during the Contest Period. No Purchase Entries will bear the same odds of winning as Purchase Entries.

PURCHASE ENTRY

Any purchase of a participating Canadian Nos Produits d'ici product at the participating Les Marchés Tradition specifically identified as a "participating product" for the purposes of the Contest or identified in Appendix 1 of these Rules, will automatically enter you into the Contest upon presentation of the Scene+® card. Each participating product (each, a "Participating Product") purchased shall earn you one (1) Entry to the Contest (a "Purchase Entry"). For example, one (1) Participating Product is equivalent to one (1) Purchase Entry into the Contest. The purchase of several Participating Products during the same transaction and upon presentation of your Scene+® card will allow the Entrant to accumulate the number of Purchase Entries relating to the products purchased. Participating Products can be identified in the Participating Stores with the 25 years in the heart of the neighborhood - Canadian Nos Produits d'ici logo. By participating in this Purchase Entry, you will be deemed to have read and accepted these Contest Rules and you agree to abide by these Entry requirements of these Contest Rules.

No Purchase Entries and Purchase Entries are collectively referred to as "Entries."

3. PRIZE AND APPROXIMATE RETAIL VALUE

A total of five (5) Prizes will be awarded for this Contest (each, a "**Prize**", collectively the "**Prizes**"). Each Prize is defined hereinafter.

GRAND PRIZE

There will be one (1) Grand Prize awarded in this Contest (the "Grand Prize") as defined hereinafter.

One (1) eligible winner (the "Grand winner") can win three hundred thousand (300 000) Scene+® points valued approximately at three thousand dollars (CAD \$ 3 000). Go to https://www.sceneplus.ca/how-it-works to see how to use the Scene+® points.

SECONDARY PRIZES

There will be a total of four (4) Secondary Prizes (each, a "Secondary Prize", collectively the "Secondary Prizes"), each valued approximately at two hundred and fifty dollars (CAD \$ 250) and consists of twenty-five thousand (25 000) Scene+® points. 4. WINNER SELECTION

There will be one (1) Draw (the "**Draw**") on Wednesday, November 15, 2023, at 11:00am Eastern Time (ET) by the Contest Organizer, in the Sobeys office located at 11281, boulevard Albert-Hudon, Montréal-Nord, Québec, H1G 3J5.

- The Grand Prize winner will be selected from all Entries collected or sent and received during the Contest Period, in accordance with these Rules; and
- The four (4) Secondary Prizes winners will be selected from all Entries collected or sent and received during the Contest Period, in accordance with these Rules.

The Prize will be awarded in the following order:

- 1. The four (4) Secondary Prizes
- 2. The Grand Prize

A grand total of five (5) Entrants will be selected (each, a "Selected Entrant", collectively, "Selected Entrants").

CONTACTING SELECTED ENTRANTS
